Annual Business Meeting

The Annual Business Meeting was held in June, and the new slate of officers is listed on the back page of this newsletter. Annual reports were also given by the officers, and these reports follow, beginning with the President's Report.

President's Report

A year ago, when we reported to you, we had no idea what the state of our Society would be when we reported to you today. We had received two severe setbacks to our Society's operation budget, and we had no idea how we would go about resolving our financial state for this fiscal year.

Over the last several years, we had come to count on the Wal-Mart Foundation and the Kirkpatrick Family Fund for total contributions of over \$5,000 to our Annual Budget of about \$12,000 to \$13,000. As with many grant funding agencies in these economic times, the Kirkpatrick Family Fund had announced its intention of changing policies as to how their funds would be dispersed. We would not be receiving the usual \$1,500 from them.

Similarly, the Wal-Mart Foundation announced new restrictions in the kind of fund raising activities permitted to receive matching funds. We could not see a way to create a fundraiser within these restrictions. Most of the suggested activities would raise only a few hundred dollars at best instead of the \$2,000 we have been raising with our Business Information Fair each year for more than ten years. With Wal-Mart's matching fund program, we had been contributing \$4,000 toward our Annual Budget with this project alone.

We had to replace this income somehow, and it took awhile to reorganize. However, you will see in a few minutes by the Treasurer's Report, that we have overcome this challenge. We have learned how to run a Silent Auction - and have a good time in the process. We have learned how to put on Half Day Seminars - and learned something in the process. We have found a format for a Beginners' Workshop which has been well received in its first three presentations. We have called on our Corporate Members to continue their support with a \$100 Annual Membership. Instead of distributing flyers about their business at our Business Information Fair, we now use our Society's brochure to advertise. We will be distributing our brochure shortly to nearby libraries and at all Tourist Information Centers for the state.

And so, as a result of a lot of creative thinking and a lot of cooperative effort, the report of our budget for this Fiscal Year is much improved over what it might have been. I am particularly proud that we are

spending more of our time and efforts on activities that fall within our mission. This is, I believe, a giant step in moving our Society forward. As we improve these fund raising activities in the years to come, we will be focusing on what is important to us and on what we do best. Good for us! To each of you who has participated in one or more of these fundraising activities, I extend hearty and sincere congratulations on a job well done!

The second big surprise for our Society this year came in the form of a check from Arvest Bank. Several years ago, Col. Charles **STANDLEY**, a local family historian, befriended Ollie **VALLIERE** - and our Society. Concerned for the preservation of his genealogy research - and having no descendants, he asked to store his filing cabinet in our library. In return, he said we would be mentioned in his will; but first, his estate must be used for the support of his two sisters. As the years passed by following his death, we understood that the care of his sisters could use all of his funds.

We were surprised then to receive a check in settlement of Col. **STANDLEY's** estate in the amount of \$33, 877.14.

I am pleased to report to you that your Board of Directors has taken the responsibility for this fund very seriously. We have agreed that we do not want to see this fund dwindle away in the payment of ordinary operating expenses. We have agreed that it should be reserved - with other smaller Society funds - for a larger, more permanent project, such as fitting into a new library facility at some future date.

With this in mind, your Board has also agreed to these points:

- 1. There is no need to hurry in finding the best use of this fund.
- 2. It is important to invest wisely and conservatively, reserving some for quick access, if that should be necessary.
- 3. It is important to gather good information before making a decision for the long term.
- 4. We want to honor the past and current support of our Corporate Members, Republic Bank, and Keith **REAMES** with an Edward **JONES** investment agency, by giving our first consideration to options provided by them (keeping in mind, that Arvest Bank is already managing a portion of our funds).

 5. The safekeeping of this fund is a priority.
- For the time being, this fund, with other Society funds for regular operating expenses, is kept in a Community Relations Checking Account at Republic Bank. This type of account is offered to local nonprofit organizations such as ours at no cost to the organization. It accrues 2.25% interest when the account is over \$10,000. The Investment Department at the bank has advised us to keep the funds there for the present, and to consider alternate investments in

about six months. The \$10,000 has been withdrawn

from the total for investment with the Edward **JONES** agency managed by Keith **REAMES**.

I am proud that the entire Board of Directors has been involved in every step of the decision-making process regarding this fund. They have been tackling many tough issues together. They are to be commended for accepting these responsibilities willingly, and with the best interests of the Society in mind.

Finally, I believe you need to know that we have been criticized for not acting in a more professional manner in regard to our fiscal responsibility. We are not professionals, nor do we currently have a professional advisor. We are continually striving to improve as we identify any issue that needs to be addressed. To that end, we'd like to invite you to share your opinion, your experience, and your resources in order to promote the growth and education of the Society's Board of Directors. We remind you that Board Meetings always have been open meetings. Anyone interested is cordially invited to attend. Currently, the next scheduled meeting will not take place until September 8. However, if you are interested in attending, please let a Board Member know, and you will receive notification if any meetings are called before our scheduled September meeting. Jo MUSTOE, President

The Metropolitan Public Library System provided us with Dr. Debra SPINDLE from the downtown branch informing us of what is available in the Metropolitan Library System, plus informing us a new branch is being opened in Cleveland County in South Oklahoma City. We met at the Goodrich Memorial United Methodist Church where we had a Silent Auction for our Christmas program which made over \$500. We toured the Western History Collection at the University of

Oklahoma. One member told us to park at the hospital and take the public bus out to the Western History Collection. This solves the parking problem. I personally can hardly wait to get back there to check on New Jersey records in the library. We had Jim IKE from the Board of the Oklahoma Genealogical Society to demonstrate the Internet. Once we even met at our own Library where we talked about what names we were working on.

I even tried a program on "Breaking Down Brick Walls" with a panel of members, Mary **LEWIS**, Lisa **SHEPARD**, and myself. We asked for you to provide us with your problems and we tried to solve them or give you ideas as to new ways to solve your problems. We have quite a success on some lines and pleased, we believe, all present.

Income. During the year just ending, our Committee deposited \$2,118.54. This is a drop from last year of \$700. The sale of our publications... cemeteries, marriages, etc., has gone down from \$1,885 last year to \$722. Anyone have an explanation for that? The figure for donations is up slightly; from \$753 last year to \$1,205 this year; the difference being almost exactly the \$338 we received from the State of California for that little research project I finally completed!

Library Committee Report

Our cataloger, Dana **Tuley-Williams**, is almost finished with the basic cataloging of our collection.

Purchases of library materials were minimal this year. The board has set aside \$700 to spend on books in the coming year. We also have some memorial funds we can spend for books and materials.

From January through May 2003, 310 persons have used our library. Of these, 74 (almost one-fourth) have been first-time users. They represent 6 states and 15 Oklahoma cities.

Some of the tenants in our library building have expanded their operations, resulting in a scarcity of parking at some times. If parking at our Library is ever a problem to you, please inform us immediately.

Major CALLAWAY and P. C. SCOTT are two of Norman's most ardent and successful sportsman and they very seldom return from their sport without a string of game in hand. We are under obligations for a present of a couple of brace of curlews from them recently, that proved to be a dainty dish that even a king could enjoy.

Yesterday Mr. W. C. **RENFROW** took his departure for Norman, I. T., where he expects to reside permanently. Mr. **RENFROW** has been a citizen of this place for many years and has held many positions of trust, in all of which he has evinced extraordinary executive ability and unimpeachable integrity. To the citizens of Norman we commend him ____ in every way worthy of their confidence and highest regard. -- Russellville (Ark) Democrat.

Mr. **RENFROW** arrived here safety Sunday but his wife and little daughter being to ill to travel, are at Eureka Springs, Arkansas. We sincerely trust they may soon recover and be at home at Norman.

On Sunday last the editor enjoyed a visit to the sprightly little city of Norman, 15 miles north of Purcell. If one doubts that Norman is a hummer, all he need to do to be convinced is for him to go there and see. The town is less than a year old, and already she has a population of close onto 2,000. Some of the best business men in Oklahoma have set pins there and are taking in the golden sheaves. Now that she has been made the county seat of the very richest county in the new territory, with clear sailing, she has, indeed, a bright future. 

Mildred SCHUSTER's Memory Garden

When long-time CCGS member Mildred SHEARS SCHUSTER plans Christmas gifts for her family, she usually shares family history in one form or another. She has provided family tree charts, scrapbooks, and bound books of family history. Last year, she created a memory book focusing on the plants in the yard of her home in downtown Norman. She has donated a copy of this book, titled "Our Memory Garden," for our Library. It is a beautiful bound book of color photos and narrative describing the plants which surround her home and their history.

The book prompted a visit from Norman Transcript columnist, Betty CULPEPPER, for her garden column, Pepper Patch, in May of this year. Ms. CULPEPPER admired iris, peonies, pink wiegelia, Rose of Sharon, and mock orange which had been planted 40 and 50 years ago. The accompanying photo features a pink smoke tree which Mildred planted in 1947.

In her memory book, Mildred describes her grandparents' (George **NEWMAN** and Charlote Fidelia STORRS SHEARS) arrival in the new town of Norman. "... one day Grandpa decided Oklahoma was the place... They arrived [in August of 1889] and settled on two lots three blocks from town. They lived in the wagon, then a tent, and finally built a one room house. The yard was prairie grass, wild flowers and weeds. At that time there were no trees in Norman. Our grandpa went to the Canadian River and came home with a small elm tree and a slipperv elm tree. That was before 1891 as he died in 1893. ... The little elm tree continued to grow and we would play, we had a bag swing. That tree was our play house. The tree was 110 years old when we had to give it up. ... We had the main limbs cut but kept the rest of the tree trunk for remembrance of those good old days with the bag swing."

The house has since been remodeled several times and remains Mildred's home. The last photo in her book pictures Mildred with her sister, Dorothy Dee SHEARS BARBOUR, on the

occasion of Mildred's 91st birthday last fall. We wish her many more happy birthdays and many happy memories from her garden.


