FEATURE

Ziba Belden: Census Enumerator

Ziba Belden was the enumerator assigned to Township 6N-1W, the portion of the 1890 first census of Cleveland County, Oklahoma Territory, which is currently being published serially in the Cleveland County Genealogical Society Newsletter.

A quick Google review of this man's life assures one that Belden was qualified for the job. In the years prior to his coming to Oklahoma, he became a lawyer, practiced law wherever he lived, was a postmaster, and even served six years as county clerk in Arkansas.

Ziba Belden was in 1890 a forty-year-old lawyer who had arrived in Cleveland County within a month after the Run into the Oklahoma Territory. Belden was born in Bloomfield, Green County Illinois, to Solomon D. Belden and Mary A. Bennett. He was the sixth child in a family of nine. In Ziba's early years the family moved to Pike County, Arkansas, where he grew up.

In young adulthood, Ziba studied the law and became a lawyer, as did two of his brothers. He was appointed Postmaster at Hot Springs December 13, 1870. He served terms as county clerk at Hot Springs in Garland County, Arkansas, in 1876-1878 and 1882-1886.

At Hot Springs, Ziba met Julia Thompson, a daughter of Fillmore Thompson, a local doctor. They married September 11, 1872. Ziba and Julia had four children while they lived in Garland County. Halley, born in 1875, died in 1879; Ernest was born January 6, 1877; Maud on March 10, 1879; and Zoe on September 17, 1881.

The Belden family later moved to Pine Bluff, Jefferson County, Arkansas. Here Ziba is said to have owned a saw mill, in addition to continuing his law practice. Another daughter, Julia, was born here, on August 9, 1886.

Apparently Ziba Belden was attracted by talk of the opening of land to settlers in the Oklahoma Territory. In the fall of 1888 he moved his family to San Antonio, Texas, to await the first land run into Oklahoma. Another son, Herbert Augustus, was born in San Antonio January 30, 1889.

The Belden family probably arrived in Norman sometime in May, 1889. Once they moved to Norman, Ziba and Julia Belden had found their permanent home, living here until their deaths. Their youngest child, Virgil Fillmore was born in Norman March 28, 1892.

The first year in the new territory was a do-it-yourself experiment. No government had been set up; there was only a rudimentary code of law; and a court system had not been established. This place would need lawyers, such as Ziba Belden.

In 1890 the federal government required a count of the influx of residents acquired during and following the Run. Ziba Belden signed up as an enumerator, counting, as of June 1, 1890, members of each family in the districts assigned to him. Belden's assignment was in the southern part of Cleveland County, including Townships 6N-1W, 7N-1W, 7N-2W, and the Town of Lexington, also in Township 6 North. This job was an advantage for Beldon, giving him the opportunity to meet and become acquainted with every family in this area of the county.

The 1890 federal census of Indian
Territory, County 3 (which would become
Cleveland County), indicates that the Beldons
had lived in this county only twelve months
on the date of the census. Pioneers who
staked a claim in the land run on April 22,
1889 report thirteen months' residence in
this first population count.

At any rate, it is quite likely that Ziba Beldon did not come to Oklahoma seeking land. He was seeking opportunity. For a seasoned lawyer arriving in a setting peopled with individuals seeking land and opportunity, and with no formal legal system in place, many would need the services he was qualified to provide. An online search of early-day Cleveland County newspapers indicates that, at least by the end of the first year in the new country, Ziba was finding work as a lawyer, representing litigants in court. In October, 1890, he ran a display ad in the *Norman Transcript*, proclaiming his services as a real estate, rentals, and collections agent. A November Professional

Cards ad for Ziba Belden, U.S. Commissioner, 3rd Judicial District, stated "Claim holders can make final proof [of their claims to land] before him at Norman" in his office in Seawell's hall.

In December of 1891, Belden was among the donors to a fund created to supplement the insufficient bonds sold in the community to secure the state legislature's decision to locate the state university in Norman. Ziba and ten other men donated ten dollars each. Some people donated more, while others donated as little as one dollar. Norman's cash contribution to secure the University for this town was successfully raised and delivered to the legislature less than a week prior to the deadline.

Later, Belden turned to politics. In
November 1892 he was listed on the
Cleveland County Republican ticket as
candidate for Probate Judge. The Democratic
party fielded no candidate for this office;
Belden's lone opponent was A.T. Ross,
representing the People's Party. [This writer
has not found the newspaper reporting the
election results; it is likely that Belden's
opponent won.]

A local news column in August 1894 reports "Ziba Belden held down the Probate Judge's office in good shape during Judge Wilkins' absence." A similar column in April 1895 noted that "Ziba Belden is now office clerk for Sheriff Newblock, and it is needless to say to all who know him, that he fills the position in an able manner."

A decade after the Run of 1889, the Norman Transcript ran an editorial comment within the *Local News* column: "No man is more deserving or more competent than Ziba Belden. He ought to have no opposition for police judge. Better withdraw, Uncle Joe, and make it unanimous." For the record, Uncle Joe did not withdraw. The popular vote was a tie,

which was broken in a unique method on May 1, 1899.

Judge Ziba Beldon He Wins Out Over Uncle Joe Wilkins After All—Draws the Lucky Ballot

The tie vote between Ziba Beldon and S.J. Wilkins was decided by lot. A number of blank ballots were put into a hat and two ballots, one containing the name of Belden and the other that of Wilkins was added to them. Councilman Mills then drew the ballots from the hat, one by one, the agreement being that the first name drawn was the winner. Mr. Mills, as it happened, drew all the blank ballots first, leaving only the two names in the hat. Amidst more or less breathless silence he then drew a ballot, which contained the name of Ziba Belden, leaving the Wilkins ballot in the hat. Mr. Belden was sworn in at once and assumed the onerous duties of his office.

Ziba Belden won this election. It appears that this judgeship lasted only a year. The Norman Transcript reported on April 12, 1900, that Belden was one of three men nominated to represent the Good Government ticket in the district judge race. Belden tallied fewer votes than either of his opponents.

Belden, however, was a longtime fixture at the courthouse. For many years he served as office deputy for Sheriff Frank Boggs and Boggs' predecessor, W.H. Newblock. Belden finally retired about 1928.

Ziba's wife, Julie Thompson Belden, died October 8, 1919 and is buried at St. Joseph Cemetery in Norman. Ziba Belden lived another decade, dying January 1, 1929. He also is buried in St. Joseph Cemetery.

Ziba Belden's survivors included three sons, Ernest, Herbert, and Philmore, and two daughters, Maud and Zoe.

In the Library

Contrary to expectations, our volunteers stay busy with work involved in preparing our library and archival materials for inclusion in the new Norman Central Library. The latest word is that the new structure will be completed and ready to be occupied sometime in late summer or early fall of 2019.

Kathryn Ramsay, genealogy librarian for Pioneer Library System, can often be found in our library, overseeing a constant migration of books from our genealogy collection to the Pioneer Library System service center, where they are cataloged and processed according to PLS standards. Once completed, these materials are returned to our shelves and are again available to researchers.

CCGS volunteers determine the fate of the books not selected for the PLS genealogy collection.

Some items are returned to our shelves, where we consider them reference material in our stand-alone library. These items will remain in the collection until it is moved into the new library.

Some books are placed on our Book Sale cart. Most of these books are priced 50 cents and \$1, although some of the better books may be priced as high as \$10.

Other books, less likely to sell in this venue, are sent to Friends of the Norman Library, to be offered to the public in their large seasonal sales.

Since You Asked ...

You are currently publishing the 1890 Territorial census of Township 6N-1W of Cleveland County. I know that my pioneer ancestors lived in this county at that time. Will I find them in this part of the 1890 census? Where exactly is 6N 1W in Cleveland County?

First we must provide a historical perspective. The current eastern boundary of our county is located *six miles east of the Indian Meridian*, which is now known as 132nd Street in Cleveland County.

The Indian Meridian, primary survey point in Oklahoma, runs from the Red River on the southern border, north to the Kansas state line. In 1889, this Meridian was the eastern border of Cleveland County. The six-mile swath east of the Indian Meridian, running the full length of our county's border, was part of Indian Territory. Those who lived in this area were not included in the Oklahoma territorial census.

The portion of that six-mile strip running north and south between the South Canadian river and the Little River was reserved for the Pottawatomi tribe, with the section between Little River and the North Canadian River reserved for the Absentee Shawnee tribe. This area was opened to settlement in Oklahoma's second land run on September 22, 1891, and the eastern boundary of our county was changed soon thereafter. These former Indian lands have been part of Cleveland County ever since.

Addressing your question: Township 6N-1W is the southernmost portion of Cleveland County's 1890 boundaries. This township is bordered by Moffat Road on the north, the Indian Meridian (now 132nd Street) on the east, and the Canadian River on the south and west.

Rural school districts included in 6N-1W include Spring Hill (#56), Stovall (#58), and Denton (#59).

The town of Lexington, also located in 6N-1W, was enumerated separately. Printing of this portion of the 1890 O.T. census will begin in the March 2018 issue.

Society Meetings

March

Twins, a boy and a girl, separated shortly after birth. Each adopted by a sister of their deceased mother. Reunited once again and raised to adulthood together. Dim memories of Mexico. These are the ingredients of the mystery retired teacher and family genealogist Diane Thompson discovered in her family history and related to us at our April meeting..

Decades passed. The girl twin died, in her nineties. Family members clearing her home enlisted Diane to research the family artifacts found among this twin's belongings.

The story was revealed. The boy twin's family, living in Mexico, experienced a tragedy. While the father was absent, a robber appeared, terrorized, and killed the mother, while two frightened little boys hid silently under the bed. In the aftermath, the bereaved adoptive father sent the boy twin back to the aunt who had adopted his sister.

Diane's message to our group was, When you discover a story like this, share it!

She shared her story on the internet, and soon received messages from three branches of this family, each with their own version to share. The full story of the Mexican affair was soon unveiled to all. This led to a joyous family reunion of strangers, held in Norman the day before our CCGS meeting.

April

Debra Osborne Spindle, librarian at the Oklahoma History Center, spoke in April on the topic, *Beginning DNA, Which Test?*

The **autosomal** test tests both parents' lines. Testers can be either male or female. Two companies, *Ancestry.com* and *23andMe*, provide only autosomal tests.

A third company, *FamilySearchDNA*, provides **autosomal** tests, but also offers two other tests that analyze other parts of your ancestry.

The *FamilySearchDNA* **Y-test** identifies only the father's direct male line, and testers must be male.

The FamilySearchDNA mitochondrial test analyzes deep ancestry for the mother's line; testers may be male or female.

Spindle concluded that DNA tests are useful, but are no substitute for traditional genealogical research.

Pioneers of Cleveland County, O.T.

Did your ancestors live in Cleveland County after the Run on April 22, 1889 and prior to statehood on September 16, 1907?

If so, they are eligible to be nominated to the Cleveland County Genealogical Society Registry of *Pioneers of Cleveland County, Oklahoma Territory.*

This Registry is a special file in the CCGS Library, consisting of materials submitted by direct descendants of each pioneer. The materials you submit in your application will be placed in the *Pioneers* file, and will be available in perpetuity to future researchers of that family.

To secure an application and instructions, call (405-701-2100), write (ccgs@csbi.org), or visit the CCGS Library (inside south entrance of Community Services Building at E. Main and 12th Avenue NE).

The CCGS Library holds many resources that will provide the proofs you are required to submit, beginning with indexes to many Cleveland County records, and including original Cleveland County courthouse records.

Library volunteers will help you access the records you need.

The deadline for *Pioneers* applications this year is Tuesday, August 15, 2017. Certificates honoring 2017 nominees will be presented at the CCGS meeting in October.

CCGS Meetings Move to Tuesday Next Year

Deaths

Alan T. Montgomery, Virginia native, 25-year CCGS member, former Board member, past president, and valued volunteer, died Monday, May 22, 2017, in Norman.

Tangible memories of Alan Montgomery will linger in the CCGS Library and Archives. Alan, a talented woodworker, built all the wood bookshelves used now in the CCGS Library. He also crafted the shelving holding the Cleveland County Tax Books in the CCGS Archives. The dedicated team of Alan Montgomery and long-time member volunteer, Ralph Wilson, created basic but sturdy shelving to store dozens of boxes of Cleveland County court records, enabling us to finally preserve all our archival Cleveland County materials under a single roof.

HISTORICAL HIGHLIGHT

45,000 Acre Ranch

Neil, Graham and Edward Johnson, sons of Mr. and Mrs. E.B. Johnson, have gone to the big Johnson ranch in the Panhandle of Texas, where they will spend a couple of months. Neil will probably remain out there and be put in charge of the ranch and its many thousands of cattle. The other boys will return for school in September.

Mr. Johnson tells the Transcript that he and his brother, Ben, of Chickasha recently purchased the Johnson & Crow ranch of 20,000 acres in the Panhandle, adding it to their other holdings of some 25,000 acres, thus giving them approximately 45,000 acres. The Johnson and Crow ranch was owned by W. H. (Henry) Johnson of this city and J.M. Crow of Isom, Texas, and they made a "killing" when they sold it to E.B. and Ben—but the two latter are perfectly satisfied to get it even at a big advance.

Mr. E.B. Johnson sold 175 head of fat cattle from his McClain county ranch last week. They averaged about 1040 pounds each and he got on an average of 8.00 per cwt., so you can figure it yourself.

Death of Old Settler

Thos. Standifer, Renowned Cleveland County Man, Passed Away at His Home Near Noble Last Monday

Thos. Standifer, one of the very best known men in Cleveland county, a thoroughgoing men in all respects, and one highly respected and esteemed by all, an old Virginia gentleman, died at his home near Noble last Monday, June 11, 1917, aged more than 85 years. ...
